### Recent Patterns of International Trade

Trade Patterns For low and middle-income countries, exports as share of regional GDP has grown sharply, eg, 26 to 55% (low-income), 25 to 55% (middle-income), and 25 to 55% (China and India) - similarly for imports Lower trade growth for high-income countries, eg, 17 to 26% in case of exports
