The Federal Selection Interview: Unrealized Potential

one end is the unstructured interview—a casual conversation where the questions asked may be unplanned and vary across interviews, and the results are analyzed and applied subjectively At the other end is the highly structured interview, where trained interviewers ask questions based on job analysis, ask the same questions of each applicant,

Interview should be grounded reality (without presenting unrealistic options) Memory Related to time - use markers relevant to the child's life (holidays, summer vacation, birthday, grade in school, etc Conclusion It can take multiple visits to accomplish one "productive" interview
